## **CONONLEY VILLAGE INSITUTE (CVIAC)**

#### 1. MINUTES OF PREVIOUS MEETINGS

# (b) Bandstand socket replacement

The Clerk received a quote for a replacement socket and cover. The Sole Trustees would like another quote for a socket with a lockable, unbreakable cover. The Clerk will contact an electrician to provide this quote.

# (c) Bowling Club sponsorship boards

The Sole Trustees received an email from the Bowling Club regarding possible funding options including erecting sponsorship boards against the wall that runs along the Playing Fields.

The Sole Trustees feel that this would not be in keeping with the aesthetics of the Playing Fields. The Trustees wish to maintain a natural look.

The Clerk will advise the Bowling Club of alternative funding options.
