#### 3. ANY OTHER BUSINESS

#### a. Funding Bid

Mr R Woolf, Treasurer of CVIAC, attended the meeting to discuss this item.

Mr Woolf gave the Sole Trustees a report on the background of the funding bid. He thanked Becky and Mark for their hard work in collecting quotes for the proposed works to improve the energy efficiency of the CVI.

The proposed works include:

- Solar panels with battery
- Double glazed windows
- Asbestos removal in clocktower
- Lighting replacement
- Thermal blinds
- False ceiling in back room
- Insulate clocktower
- Underfloor insulation & new carpets

Mr Woolf explained that 2 quotes were required in order to apply for the funding, many quotes were received. The funding bid requires 20% match funding, CVIAC will be providing £10,000 towards the works which will come from the Development Fund. The General Reserves will be used to pay the VAT element of the works, this will be reclaimed and returned to the Reserves.

The works are planned to take place over the summer holidays.

RESOLVED: The Sole Trustees approved the funding bid in its entirety.

RESOLVED: The Sole Trustees approved the use of the £10,000 from the Development Fund.
